300 Business arising

The one motion that was pulled out of the December SAC meeting was concerning the Flag Football Field length motion. The motion did not pass (50% +1) given that the vote was 11-10-8.

Unfortunately, what is currently in the handbook, status quo, is not actually used so it's not an option either. We had a meeting with the flag referee assignor, explaining the field length rule and the main issues of using the 18-yard box as the goal line instead of using a floating goal line and the limitations that this places on the use of fields. We have proposed to meet with a committee, that includes the referees, prior to the start of next season, to come up with a solution to use the soccer fields (with soccer lines) that does not change the nature of our current rule – the idea of fixed lines becoming the goal lines, or a semi-floating goal line was discussed. We will work with the referees to see how we can put this in effect for the 2024-2025 season and use the solution for one year (2024-2025). After that we will examine the results at the May Competition Committee meeting in 2025 to see if we can improve or adjust it.

401 Board of Directors Report

There were two things that came out of the Board Meetings that didn't pass through SAC first. They are both concerning fees.

Membership Fees Adjustment: The member fees in 2024-2025 will be analyzed at the Board Meeting in September, as they are set to increase by 2%. After reviewing the first draft of the financial statements, the Board will decide on the possible increase.

Adding HR Costs into the per team fees: We are in year 3 of the financial plan to wrap HR fees into the team fee costs. This means there will be a categoric increase in all team fees again next year. The amount of the increase will be confirmed on Friday at the final Board of Directors Meeting.

402 Competition Committee Recommendations

They are not permitted to return to the game premises until their subsequent suspension has been served.

403 Invoices / Spring Statements

The bills have been sent to the bookkeeper. Once they come back to the office, they will be sent by email to the SAC reps. Please send payments in as soon as possible since our books close on June 30th and things need to be sorted out by then.

Again, the process for next year is that you will only be invoiced a pre-season amount for leagues. This amount is sent by email to the SAC Rep from Amanda about 1-2 weeks after the scheduling meetings for that season (Fall – September/October, Winter – November/December, Spring – April). For all day-long events, you will be invoiced only on the invoice at the end of the season. (Fall – December, Winter – April, Spring – June)

Please note, if we do not receive your payments for leagues by the time the seasonal bills are processed, a 15% surcharge is added to those costs.

404 Year-end Summary 2023-2024

The number of teams in 2023-2024 increased again by 106 total teams from last season. This is a 152 team jump from our last pre-covid year (2018-2019) which is almost a 12% increase. The two new sports for this year were Pickleball and Water Polo with 14 and 13 teams respectively.

As you know, with the increase in teams, comes at times an increase in ejections, withdrawals and discipline issues, this year we had a 22% increase in ejections, 23% increase in defaults, and we had almost double the withdrawals from last year. In the office we discussed the possibility of adjusting the Coaches Commitment Program for a re-vamp. We thought it would be a good idea to adjust the program slightly, to add new information, suggestions and possible resources to the list. This would mean that all coaches would have to do the program again and perhaps would allow us to put more of a focus on sportsmanship. Many of the ejections in the leagues were due to abuse of officials, it is imperative that we continue to treat the officials with respect, without them we don't have sport.

With an increase in the number of teams, there is obviously also an increase in games as well. As you all know, it is becoming harder and harder to find referees. For basketball specifically we are planning a meeting with MMBRA to see what can be done for our teams. One of the solutions is the possibility of Bantam D4 teams to provide their own referees for games. Teams would know this in advance (prior to registration) and

we would set up a few mini clinics with schools to train individuals to referee those games. The suggestion is to train grade 10-11 students who would be around and able to cover those games in your school. This will be announced at the August SAC meeting, so all schools are aware prior to their registration.

The amount paid out to the in-house referees was inquired about, the referees felt they should be receiving more money when refereeing in-house as there are no administrative fees.

It was requested to share access to the coach's commitment program with the SAC reps.

405 Calendar 2024-2025

Please look at the calendar and let the office know if anything drastically stands out and should be changed.

Some things to note are when the fall season team entries are due, given that those happen relatively quickly. Soccer team entries will be due September 4th at noon. As of right now there are two options for outdoor track & field, ideally, we use option 1, but the factors are: photo finish availability, track availability, and exam schedule in May. Please let us know ASAP if there are any exams on HALO.

Next year follow the same procedure and have the August and December SAC meeting on zoom and the June meeting in person.

407 Pre-Payments 2024-2025

A sheet with the pre-payment amounts will be posted and shared once the spring bills are completed and the HR amounts are approved by the Board (after the final Board meeting on Friday, June 14). The first draft was shared on the screen.

All costs have increased over the last few years and the pre-season payments must consider all these increases. We have budgeted for a 4.5% increase in referee fees, officials' fees and rentals, this is based on the Consumer Price Index of this past year. The office administration fees for the teams have also increased to accommodate the possible HR fees of the office staff. (Again, this will only be confirmed Friday).

This year we will separate the two types of payments on the sheet so that schools can visualize where their payments are going. For example, the Admin HR category includes Awards, Equipment, First Aid, Provincial Transportation, Office Costs, HR Fees, etc. And the Refs/Rentals category includes referee costs (for a maximum possible number of games), rental costs for facilities, officials' fees, federation affiliation fees, etc.

Keep in mind that this is a budgeted or pre-season amount. For the leagues, if the amount exceeds the pre-season amount, the school will receive an invoice for the difference at the end of the season. Conversely, if the amount is less than the pre-season amount (or the team plays fewer games than budgeted), the school will be credited with the difference at the end of the season. For day-long events or tournaments, the school will only be billed after the fact, so these amounts are an educated estimate of what the costs will be.

408 Age Categories 2024-2025

The age category sheet has been updated and shared, there have been some adjustments to certain sports (Rugby & Lacrosse). Prior to registering your teams next year, please make sure to confirm the age categories for the specific sport as they do vary from sport to sport.

409 RSEQ Report

RSEQ Financial information: There will be some adjustments to our financing coming from the Government through the RSEQ in the next year. Here is the main information that you need to know about this.

All 14 Regional associations will be unifying under the RSEQ banner, this unification is a step that all regions are taking to be in line with the Law – LCOP.

The RSEQ has received written confirmation by the Minister of Education and the Treasury Board that we will be officially recognized as the organization in charge of school sport. This is the first time ever that the RSEQs will be recognized for their mission of education through sport.

Over the next year, all regions are working together on unification, we are a part of the process at each step and will continue to prioritize our region.

The objective is that our end-users (member schools) do not see a difference in our services, our calendar, our language and our price point, in theory if our members experience a change, it will be for the better.

More information will be released through June and in October after the AGM of the RSEQ. Schools, SAC Reps and principals will be kept informed of the developments.

Provincial Hosts

This past year, the RSEQ GMAA helped to host two provincial championships along with two of our member schools. Thank you so much to Andy and the staff at Laurier MacDonald for their help with the lodging at the Indoor Track & Field Provincials in April. Also, congratulations to Selwyn House School for successfully organizing the Juvenile boys' level of RSEQ D3 Basketball Provincials. The weekend was a huge success. If anyone is interested in hosting a Provincial in 2024-2025, please let us know.

410-1 MVP & Sportsmanship
